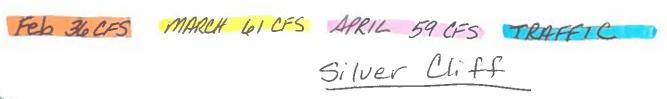

Fox Run Subdivision:

1 new single-family home (100 Fox Run Circle \$375,000) started on April 8th. Crestone Concrete & Construction is the contractor 306 and 109 Fox Run are nearing completion

Town Hall:

Safety rail to be installed around new sidewalk when material arrive

Planning Commission:

Workshop for updating Title 16 (Zoning) in the Municipal Code held at 5 PM on Thursday April 3, 2025. Passed updates to Title 16 however, additional changes have been requested by Steve Swiatek of Silver Peak Properties (New owner of COSI Silver MHP). Has plans to clean up the park. Also working on updating all of the towns zoning and omitting 2018 IZC from our municipal code

Ben Troyer with Oak Ridge Homes purchased 60 acres East of town and is proposing a residential sub-division with approximately 100 lots ranging from ½ to 1 acre each. May also include a small business park.
